Mississauga Grand Banquet & Event Centre Thursday, May 4th, 2023 4:00pm

1. Call to Order

The meeting was called to order by President Deb Goudreau at 4:05 p.m. Deborah welcomed attendees and thanked everyone for participating in this event. Deborah reviewed the agenda and introduced herself as well as the other speakers Scott Tam, Secretary Treasurer, Marcus Firman, AWWA Director and Michele Grenier, Executive Director.

There were 26 voting members in attendance on site, and 37 proxies were received. Deborah then introduced the board and staff. She also welcomed Cody Finan from AWWA and thanked him for attending.

Deborah reviewed the procedures for voting at the AGM. The Ontario Not-for-Profit Corporations Act provides the opportunity to OWWA members to cast their votes by proxy or in person at the Annual General Meeting. One must be a member in good standing as of December 31, 2022 in order to cast a vote. Those members who are present at the AGM, and who have not voted in advance, are eligible to vote.

2. Approval of the 2023 Agenda

Deborah asked for a motion to approve the agenda items presented for the 2023 AGM.

4. Business Arising from the Minutes

There were no action items arising from the 2022 AGM Minutes. There will be an opportunity for new business at the end of the meeting.

5. Report of the President

The Association continues to implement the 2020-2023 strategic plan. Deborah reviewed four key objectives on which the association had focused in the past year:

- Continue to build an inclusive culture that encourages, supports and celebrates the diverse voices of our members to fuel innovation and collaboration.
- Promote AWWA's Total Water SolutionsTM resources for the water community
- Continue to develop the volunteer leadership's ability to guide and oversee OWWA
- Leverage OWWA's credibility with decision-makers & Identify priority risks to safe drinking water and advance policies to address them

The Diversity, Equity & Inclusion Working Group completed the development of the association's DE&I Action Plan, which was approved by the OWWA Board in June of 2021. The Diversity & Member Engagement Committee will be releasing a DE&I "benchmarking" survey on May 9.

With regards to the second objective, OWWA continues to collaborate with our partners at WEAO on matters of mutual interest, and we are excited to host the first ever OWWA-WEAO Joint Conference and Trade Show in Niagara Falls, from May 5 to 7 next year.

The Board and staff continue to look for opportunities to foster future association leaders within the membership. A few programs that were implemented or maintained in 2022/2023 include:

- 1. The Mentorship Program was offered again in October 2022 and has 15 mentor/mentee pairs.
- The Board updated its meeting attendance policies to allow for participation from a broader range of individuals, including Committee and YP leaders.
- 3. DE&I Training for Board, staff and DMEC members is planned for June of 2023 as part of the overall strategy to ensure that OWWA is an environment where all our members feel welcome and see themselves reflected in the association's leadership.



The Board also recently launched the OWWA Advocacy Steering Committee, to advance policy on water issues through active participation in regular meetings with the MECP and other ministries, as well as with other like-minded organizations.

Looking forward, planning for the next Strategic Plan cycle will kick off in June after ACE. Deborah reminded attendees that ACE23 will be taking place in Toronto and in 2024 the annual conference will resume as a joint conference with WEAO in Niagara Falls.

Deborah introduced the incoming President, Ed Bertolo and Vice President, Scott Tam.

Deborah called for a motion to accept the President's Report as presented.

6. Report of the Secretary-Treasurer

Scott Tam introduced himself as the 2023-2024 Secretary-Treasurer.

OWWA's finances have improved in 2022 and are essentially back to pre-pandemic levels. The return of the in-person conference had a positive effect on total revenues. OWWA also saw growth in other revenue streams, particularly Publications and Job Postings.

The CCC Certification Program also saw a return to "normal" operations.

OWWA is in a very strong financial position after several years of surpluses. Drawing from the reserves has not been necessary.

Scott presented the Statement of Financial Position and Statement of Operations for 2022, and asked for a motion to accept the Secretary-Treasurer's report.

7. Report of the AWWA Director

Marcus Firman introduced himself as the 2021-2024 AWWA Director for the Ontario Section.



Marcus introduced the 2023-2024 AWWA Officers and provided an overview of the 2025 AWWA Strategic Plan, which is focused on member engagement and development, knowledge creation and exchange, water policy and leadership, and organization stewardship.

Marcus provided AWWA's 2023 Status Report which noted that AWWA currently has 50,588 members and that membership has increased over the year, surpassing the 2023 end of year goal.

Marcus introduced AWWA's new initiative, Water2050, which seeks to establish a long-term vision of the future of water. The goal is to engage in thoughtful, intentional and inclusive discourse that results in bold, achievable goals.

Marcus noted that ACE23 will be co-hosted by OWWA in Toronto from June 11 to June 14. He highlighted registering in advance for the No Water... No Hockey Game on June 11 and the Canadian Water Forum on June 12.

Marcus called for a motion to accept the AWWA Director's Report as presented.

Michele Grenier introduced herself as the OWWA Executive Director. Michele provided updates on the OWWA membership (as of Dec. 31, 2022) including a breakdown of individual, service provider and utility members.

She also offered highlights of 2022 events, including the first ever virtual conference & trade show, committee webinars, and networking events.

Looking ahead to 2023, the association is looking forward to a return to in person events. Other priorities will be to:

- Working more closely with Area Conferences
- Working with DMEC to advance the implementation of the DE&I Action Plan and its next iteration
- Continue to strengthen strategic partnerships
- Supporting advocacy & policy work
- Establishing the Education & Outreach Task Force to address workforce issues



9. Election of New Directors & Appointment of Secretary-Treasurer

Deborah introduced the two new Directors of the Board of Directors 2023-2026, Blair Saunders and Jesus Garcia Aleman, and Tom Woodcock as incoming Secretary-Treasurer for 2022-2023.

Given that only two nominations for the Board were received, both candidates will be acclaimed subject to ratification by the OWWA membership. Deborah then called for a motion to accept the slate of candidates as presented.

Emily Stahl – Manager, Technical Services, City of Guelph

Emily Stahl is the Manager, Technical Services in the City of Guelph's Water Utility. In this role she is responsible for the technical team that supports the operational division. This includes management of

capital programs, hydrogeology, water supply management and planning and source water protection. As Guelph is reliant on groundwater for their municipal water supply these roles ensure the long-term sustainability and protection of the resource.

Emily is a Professional Geoscientist (P.Geo.) with a master's in water resources engineering possessing significant government and private consulting-based experience in integrated water management, water resource planning, source water protection and associated technical studies and stakeholder engagement processes. Her experience has included working in both the private and public (municipal and conservation authorities) sectors.



Emily is currently the Chair of the OWWA Groundwater Committee and has served as a trustee and committee member in the AWWA's water conservation division.

James Sticca – Manger of Public Works, City of Welland

James joined the Ontario Water Works Association (OWWA) as an individual member in 2009. Since then, he became a member of the South Central Water Works Association (SCOWWA) Board of Directors in 2016 and current serves as the SCOWWA Chair, and has also been a member of the OWWA Distribution and Publications Committees since 2018.



James started his water career in 2007 with the City of Port Colborne, moved to the City of Niagara Falls in 2008. Presently he is the Manager of Public Works with the City of Welland. Throughout his career, James has held a variety of roles including Operator, DWQMS Coordinator, Water/Wastewater Manager and now Manager of Public Works overseeing the Water, Wastewater, Roads, Fleet and Stockroom operations at the City of Welland.

The OWWA is a voluntary not-for-profit association that finds its strength and defines its purpose through its Vision, Mission Statement, and Core Principles. It implements its Strategic Plan by generating objectives and actions through Strategic Goals.

The organization's first strategic plan was created in 1995 and is reviewed and updated every five years. The OWWA's current 2020-2023 strategic plan was presented to the membership and adopted at the 2020 Annual General Meeting.

A Strategic Plan Steering Committee was struck by the Board and Chaired by the OWWA Past President, Deborah Goudreau. The other members of the Steering Committee included:

- Marcus Firman a Past President of OWWA (2017-2018) and current AWWA Director for Ontario (2021-2024)
- Scott Tam OWWA Vice President (2023-2024)
- Sonya Semanuik OWWA Director (2022-2025)
- Michele Grenier OWWA Executive Director

The OWWA's 2024-2026 Strategic Plan has been developed in consideration of updates to the AWWA 2025 Strategic Plan, recent changes to strategic partnerships, future joint events, and other key issues affecting the water industry.

The Steering Committee consulted with Committee Chairs and Vice-Chairs during OWWA's Leaders' Day in October 2023 and presented the draft Strategic Plan for approval to the Board of Directors on January 25, 2024.

The proposed OWWA 2024-2026 Strategic Plan is being presented for adoption by the OWWA membership at this 2024 Annual General Meeting, in accordance with the OWWA Bylaws and Standard Practice Manual.
