## A. Water Loss Management

(Hetek)

The Water Loss Management course outlines a theoretical and practical understanding of a water loss strategy for utility drinking water managers, operators, and technicians. (0.7 CEUs)

- Flow and pressure monitoring as a broad system approach
- Project planning towards acoustic watermain testing
- Water leak detection technologies
- Analysis of data from acoustic leak detection instruments
- Operation of acoustic leak detection instruments

## B. Environmental Compliance 101

(Acclaims Environmental)

While some provisions to standard rules are included in your Municipal Drinking Water Licence and your Environmental Compliance Approvals, this course provides an overview of environmental legislation that applies to your activities. **(0.7 CEUs)**

- Canadian Environmental Protection Act and related regulations
- Fisheries Act and related regulations
- Transportation of Dangerous Goods Act and related regulation

A one-day course on sodium hypochlorite covering identification, properties, storage, handling, first aid, spills, chlorine chemistry, and calculations. (0.7 CEUs)
