- Should a successful applicant be employed as an underfill Operator, he/she will be required to write and pass the required Class 1 certification exams and Limited Surface Water or Ground Water subsystem within 90 days from their start date.
- Must be available for overtime and able to be on-call after regular working hours as part of a rotation.
- Valid Class G driver's licence.
- The successful candidates must be able to respond to on-call within a reasonable period of time.

Knowledge

- Good knowledge of water and wastewater treatment processes to operate the facilities.
- Working experience in/knowledge of the skilled trades for the maintenance and repair of a variety of equipment and structures, including, but not limited to, the following skills: basic electrical repair, welding, plumbing, millwright, gasfitting and steamfitting.
