- Keep abreast of Vale policies, legislated standards, design criteria, and industry best practices related to wastewater treatment and potable water production.
- Accept and process 1st stage grievances for treatment plant operators. Liaise with the area Human Resources Business Partner and Superintendent on CBA-related issues.
- Available at all times to direct the Operators in Charge (OIC) for operations of the potable & wastewater treatment plants, to provide operational oversight, and to respond immediately and effectively to emergencies.
